If successful bidders unable to make payment /refuses to take the car in due time, security money will be forfeited without any notice.
2. Bidders should clearly mention their address and super scribe “**Quotation for purchase of Car bearing Regn. No- No- OD-21-F-7557, Model 2017**” on the top of the envelope.
3. Successful bidder shall deposit full payment of total sale value including GST to IFFCO by way of **Demand draft/ cheque drawn in favour of “IFFCO Ltd.” payable at Paradeep/ Musadia Branch** within 15 days from the date of sale order, failing which penalty will be charged @ 1% per week or part there of subject to maximum 5% of total sale order value. Documents for transfer of vehicle will be handed over after receipt of full payment.
