To hold the IOA election, to elect the above members, the following programme is hereby announced:-

DATE, TIME & VENUE:

The Election will be held on 31/07/2024 from 06.00 hrs to 15.30 hrs in the Training Hall of New Technical Building.

2. CANVASSING FOR THE ELECTION:

- a) Interference of any Outsider and/or other than member of the Association in the canvassing of Election is strictly prohibited. Canvassing is not allowed after 10.00 P.M. of 30.07.2024.
- b) Any kind of gathering during election period regarding election is strictly prohibited.
- c) Display of any Pamphlets/Posters and use of official email is strictly prohibited, failing which the candidature of the candidate, found doing so, will be liable to be rejected.
- d) Cooperation of all concerned is solicited to maintain discipline, peace and harmony during canvassing and election period.

3. During the election hours, only the election committee members will be present in the polling booth and the voters will be allowed to enter the polling booth one by one.

4. PROCEDURE FOR VOTING

a) The voters of the concerned grades, strictly as per the list of voters, will be allowed to cast their votes as required in different grade Executive Member as indicated above in the final list of candidates & all members will be allowed to cast their votes for Office Bearers.

b) Carrying Mobile Phone inside the Polling station is strictly prohibited, failing which

voter will be liable to be barred from voting.

 c) The voting will be through SECRET BALLOT. d) The voter will be required to obtain the prescribed ballot papers duly signed by the Polling officer and Ch.EO/EO at the venue by acknowledging the receipt of

the ballot paper on the list of voters.

e) After obtaining the ballot paper, the voter will be required to cast his/her vote in the BOOTH meant for the purpose by putting a rubber stamp (SWASTIK NISAN) against the candidate(s) of his/her choice.

f) After casting the vote in the above manner, the voter will be required to insert the ballot paper in the prescribed ballot box available in the polling station in

presence of the officials conducting the Elections.

g) All the voters have to cast their vote for Executive Member in their grade/post only. For e.g. in Grade H1/G2/G1 - Each voter has to cast their vote for Three Candidates only. If any voter casts less or more than the required number of candidates, then it will be treated as invalid.

h) At the time of election, the voter invariably has to show their ID Card to the Election Committee.

i) In case, voting stamp (SWASTIK NISAN) crosses the top or bottom line in the ballot paper more than half it may be considered at the discretion of Election Committee. The decision of the Committee will be final and binding.

If any member employee proceeds for official tour or leave on Election Day, they may cast their vote after submitting the proof of approval/ sanctioning of tour

/leave before the committee on 27.07.2024 (1000 -1200 Hrs).

5. COUNTING OF VOTES: -

The counting of the votes shall be done by the Election Committee Members immediately after the voting is over. The counting shall be done in the presence of the candidates or their authorized representative whose number shall not exceed one for each candidate. In case of tie, the winner for the post will be decided based on coin toss / lottery as decided by the Chief Election Officer.



6. DECLARATION OF ELECTION RESULTS

On completion of the counting, the names of the candidates elected shall be declared and notified on the same day i.e. 31st July, 2024.
