NOTICE

Sub: Election of **Executive Committee Members** of IFFCO Employees Union, Paradeep For a period of 2 years.

Notice is hereby given for holding the biennial Election of the Executive committee members of IFFCO Employees Union, Paradeep for a period of 2 years.

1. CONSTITUENCIES:

The total number of the Executive committee members to be elected is 19. The number of executive committee members to be elected from each constituency will be as per attached annexure – 1.

2. ELIGIBILITY FOR VOTING AND CONTESTING:

- a) Only such workmen who are the members of IFFCO Employees Union as on **31/03/2012** will be eligible to contest and vote in the elections.
- b) In this connection a constituency – wise list of voters is enclosed herewith.
- c) A member will be allowed to contest and vote only from the constituency in which he/she is a voter.
- d) The Proposer and Secunder of the candidates must be from same constituency.

3. ISSUE OF NOMINATION FORMS:

- a) The candidates contesting for elections are required to file the nominations only in the prescribed form duly serialized and countersigned by Returning or Assistant returning officer (RO or ARO).
- b) The candidates wish to contest for the elections can get the nomination form from the RO or ARO between 10.00 hrs to 12.00 hrs. And 14.00 hrs to 16.00 hrs on all working days from **16/04/2012 to 18/04/ 2012**.

4. FILING OF NOMINATION:

- a) The candidates contesting for elections can file the nominations between 10.00 hrs to 12.00 hrs and 14.00 hrs to 16.00 hrs on all working days from **16/04/2012 to 18/04/ 2012**, with RO / ARO.
- b) The nomination papers should be clearly filled (candidate name in block letter) in with full details and should be signed by the candidate contesting along with Proposer and Secunder.
- c) **A member can propose or second only one candidate belonging to the same constituency.**

5. SCRUTINY OF FORM:

- a) Scrutiny of the nomination papers will be done at **17.00 hrs on 18 April 2012** in the conference room of old main building in the presence of the candidates or Proposer or Secunder.
- b) If a candidate or his proposer or his seconder is unable to be present at the time of scrutiny, he may send a duly authorized representative (in writing), for the above purpose.

6. REJECTION OF FORMS:

The nomination papers may be rejected on the following grounds:

- a. In case the candidates and / or his Proposer and / or his Secunder are not eligible to vote in the particular Constituency for which nomination has been filed.
- b. In case, the nomination is not filed in the prescribed form.
- c. In case the signatures of the candidate and / or Proposer and / or Secunder are not genuine and have been obtained without full consent.
- d. In case the nomination paper is not filled clearly and all the required details are not fully furnished.
- e. In case any voter proposes and or seconded more than one nomination.
- f. Overwriting and cancellation of any entry will disqualify nomination form.

The decision of the Returning Officer in all respect of rejection or otherwise of the nominations will be final and abiding to all.

7. WITHDRAWAL OF THE NOMINATIONS:

- a) The candidature for election can be withdrawn on **19/04/2012 to 20/04/2012** between 10.00 hrs to 12.00 hrs and 14.00 to 16.00 hrs.
- b) The notice for withdrawal from the candidate should reach the RO or ARO in writing duly signed by the candidate in the prescribed form which can be obtained from the RO / ARO.
- c) No candidate shall be allowed to contest the said election under any circumstances who has given a notice of withdrawal of his candidature.

8. LIST OF CANDIDATES CONTESTING FOR ELECTIONS:

The final list of the contesting candidates for elections will be displayed on the Notice Board and in mail circular on **21/04/ 2012**.

9. ELECTIONS:

- a) In the constituencies where Elections are required, such Elections will be held on **23/04/2012** between 05.30 hrs to 15.00 hrs.

- b) All the contesting candidates or their authorize representatives must be present 15 minutes before polling starts to check the ballot box.
- c) The voting shall be conducted by secret Ballot. **The detailed program for elections, wherever required, will be notified separately.**

10. COUNTING OF VOTES:


The counting of votes shall be done by the undersigned immediately after the election is completed. The counting shall be done in the presence of the candidates and / or their authorized nominees, whose number shall not exceed one for each candidate.

11. DECLARATION OF ELECTIONS RESULTS:

On completion of the counting, the names of the candidates elected shall be declared and notified on **23/04/2012** itself.

12. MEETING OF ELECTED EXECUTIVE BODY:

- a) The executive body will meet on 24/04/2012 to select their office bearer (one President, one working President, one Vice president, one General secretary, one Organizing secretary, one Joint secretary, one Publicity secretary and one Treasurer) as per union by-laws.
- b) In case of any dispute for any post there will be open election for the post of unselected office bearers.
- c) If necessary further notification of election for unselected office bearers will be issued separately on 25/04/2012.
