Order No 15219 // EMG//Dt. 23-12-2021

WHEREAS, SARS-CoV-2 infection continues to be active in different areas in the State and some parts of the country and it is necessary to strictly adhere to COVID-19 safety protocols for containment of spread of the infection;

AND WHEREAS, the Govt. of India in the Ministry of Health and Family Welfare and Ministry of Home Affairs have issued different SOP & guidelines for strict surveillance and enforcement of COVID-19 protocols;

AND WHEREAS, the State Government vide Order No:- 6773/R & DM (DM) dt. 30.11.2021, have issued guidelines for graded unlocking with a view to protecting the health of the public and preventing spread of COVID-19 alongwith normalising the economic activities with strict adherence of COVID protocols.

AND WHEREAS, Govt. of Odisha has directed Collectors/ Municipal Commissioners may impose any additional restrictions as may be felt necessary in the interest of containment of COVID-19 and to ensure COVID appropriate behaviour are followed by all concerned.

AND WHEREAS, Govt. of Odisha has directed Collectors/ Municipal Commissioners may impose appropriate restrictions on entry of devotees into temples/ churches/ mosques/ religious places /places of worship considering the local conditions in view of the prevailing pandemic situation strictly adhering to the COVID-19 safety protocols.

NOW, THEREFORE, in exercise of the powers conferred to me under 24(l) of Disaster Management ACT, 2005 read with rule 8(1) of the Odisha Disaster Management Rules, 2010 and in larger public interest with a view to contain the spread of COVID-19, I Mrs. Parul Patawari, I.A.S., Collector and District Magistrate, Jagatsinghpur being the empowered officer do hereby direct to implement following orders;

All the temples/churches/ mosques/ religious places /places of worship will remain closed on dt. 25-12-2021, 26-12-2021, dt. 31-12-2021, dt. 01-01-2022, dt. 02-01-2022 for Darsan/Entry for devotees/public in apprehension of large gathering/congregation and failure of adherence to COVID-19 protocols. However, the religious rituals will continue as usual.
