
Order No. 3579 /dt. 19.06.2020


ORDER

The Hon'ble Supreme Court of India in the case of Odisha Vikash Parishad- Vrs- Union of India and others in W.P (C) No.571/2020 has been pleased to pass the order quoted as follows "We accordingly direct that there shall be no Ratha Yatra anywhere in the temple town of Odisha or in any other part of the State this year. We further direct that there shall be no activities secular or religious associated with the Rath Yatra during this period." Accordingly the trust board/Executive Officers/Person-in-management of the religious institutions are not to perform the Ratha Yatra and associated secular or religious activities connected therewith as directed by the Hon'ble Supreme Court of India followed by State Govt. Resolution Dated 18.06.2020 and communicated to this office vide the Law Department Govt. of Odisha, Bhubaneswar Letter no 5498 Date 19-6-2020. The Collectors-cum- District Magistrates of the Districts in the State of Odisha are hereby requested to enforce the directions of the Hon'ble Supreme Court of India mentioned hereinbefore.
