

Nomination papers in the prescribed Form duly filled in shall be handed over by a Candidate or his proposer / Seconder to the respective Returning Officer (RO) at Aonla & Paradeep, as the case may be, between 11.00 AM to 4.30PM on all working days from 14.05.2014 to 20.05.2014 (both days Inclusive). However the receipt of nomination shall close at 4.30 PM on 20.05.2014(Monday).
