As you all know that Heavy rainfall, cloud bursts, landslides and floods caused widespread loss of life and property displacing hundreds of people in Pauri, Chamoli and Rudra Prayag districts of Uttarakhand on June 16, 2013. Thousands of locals and pilgrims have been affected. Many kilometers of roads have been washed away and many bridge roads, bridges, residential buildings, water lines, canals, check dams, electricity lines, power houses and other public and private property have been severely damaged besides lives of the villagers, live stock/cattles and pilgrims.

2. Rescue operations in the flood hit northern Indian state of Uttarakhand is being carried out by the Army and Air Force personnel alongwith the local administration and are in full swing. About 70,000 to 80,000 survivors in different parts of the state have been evacuated from flood ravaged areas in the State of Uttarakhand while several people remain stranded.

3. IFFCO Kisan Sewa Trust – Trust created by IFFCO with a aim to provide relief to the areas/victims affected by natural calamities. IFFCO Kisan Sewa Trust has already provided the relief & rehabilitation to the earth quake victims of Gujarat in the year 2001 and T-Sunami in Indonesia, Sri Lanka and India in the year 2004.
