1. DATE, TIME & VENUE:

The election will be held on 23/04/2012 from 05:30hrs. to 15:00 hrs. in the Training Hall of old administrative building.

2. CANVASSING FOR THE ELECTION:

- a) Interference of any Outsider and/or other than Member of the Union in the canvassing of Election is strictly prohibited. No canvassing will be allowed after 10: 00 p.m. on 22.04.12.
- b) Any Kind of gathering during election will not be allowed surrounding 50 meters of Voting place.
- c) All are requested to maintain discipline, peace and harmony during canvassing and election period.

3. OFFICIALS TO CONDUCT THE ELECTION

Besides, Election Officer, Returning Officer and Assistant Returning Officer the following officials will be conducting election:-

During the election hours, only the above officials will be present in the Polling Booth and the voters will be allowed to enter the Polling Booth one by one.

4. PROCEDURE FOR VOTING

- a) The voters of the concerned Constituencies, strictly as per the list of voters already circulated, will be allowed to cast their votes in favour of one or two candidates as required in different constituencies and indicated above in the final list of candidates for Election.
- b) No voter will be allowed to carry **Mobile Phone** inside the Polling station.
- c) The voting will be through **SECRET BALLOT**.

- d) The voters will be required to obtain the prescribed ballot papers duly signed by the Polling officer and RO / ARO at the venue of voting by acknowledging the receipt of the ballot paper on the list of voters.
 - e) After obtaining the ballot paper, the voter will be required to cast his/her vote in the BOOTH meant for the purpose by putting a rubber stamp(X) against the candidate(s) of his/her choice.
 - f) After casting the vote in the above manner, the voter will be required to insert the ballot paper in the prescribed ballot box available in the Polling Station in presence of the officials conducting the Elections.
 - g) All the voters have to cast their votes(one or two) from one constituency only as per the attached annexure-1 of above Notice.

For Example: In constituency No.1- Each voter has to cast their vote for two candidates only.

In Constituency No.2 - Each voter has to cast their vote for one candidate only.

If any voter cast for less or more than the required number of candidates, then it will be treated as invalid.

- h) At the time of election, all the voter has to show their Punching card / Id proof to Election Committee.
- i) In case, voting stamp crosses the top or bottom line in ballot paper, then it will be treated as invalid.

5. COUNTING OF VOTES

The counting of the votes shall be done by the undersigned and the other officials for elections, whose names are given above, immediately after the election is over. The counting shall be done in the presence of the candidates or their authorized nominees whose number shall not exceed one for each candidate.

6. DECLARATION OF ELECTION RESULTS

On completion of the counting ,the names of the candidates elected shall be declared and notified on the same day i.e. 23rd April 2012
