A District Level Meeting of the endowment stakeholders for opening of all Temples and other religious places of Jagatsinghpur district was held on 25.08.2021 at 12.30 P.M. in the Sadbhabana Sabha Gruha, Collectorate, Jagatsinghpur under chairmanship of the Collector & District Magistrate, Jagatsinghpur . List of members present in the meeting is at Annexure-A.

At the outset Additional District Magistrate, Jagatsinghpur welcomed all the members and thereafter the Collector & District Magistrate, Jagatsinghpur briefed the house about the objectives of the meeting.


- As per Government guidelines, all the temples/ religious institutions of the District will be opened w.e.f. 06.08.2021 with strict adherence to COVID-19 guidelines/ protocols.
- Maximum 100 persons will be allowed in a day and 10 persons will be allowed at a time with a line maintaining proper social distancing to the temple. No one will be allowed to Garva Gruha.
- Hand washing/ sanitizing facility to be provided by the **temple authority/ managing committee.**
- No person will be allowed without wearing mask inside the temple premises.
- The devotees should be allowed to the temple from **7.30 A.M. to 1.30 P.M. and 3.00 P.M. to 6.00 P.M.**
- The period of stay of devotees inside the temple should be very short.
- **No Prasad/ Bhoga** shall be offered by the devotees in the temple.
- The Concerned I.I.Cs were instructed to control the crowd inside and outside the temple.
- All the Sebayata & staff of the temple along with devotees with ILI/ SARI symptoms and suffering from fever, cold or any other COVID-19 symptoms shall not be allowed to the temple.



- The temple authority/ managing committee were directed to sanitize the temple every day.
- The Trust Board/ Person in management shall ensure the adherence of above modalities by the devotees and sebayats and take disciplinary action against the sebayats for violating the above modalities and against the devotees by lodging F.I.R.


At the end basing on the order No.4290/R&DM (DM) dated 31.07.2021 point No. E (i) and discussion in the meeting, it is unanimously decided that all religious institutions of Jagatsinghpur District will be opened w.e.f. 06.08.2021 after observing the above modalities till 1st September, 2021 as per the order of the Special Relief Commissioner vide Order No.4290 Dt.31.07.2021.




